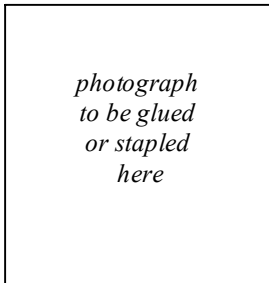

- A **NATIONAL LICENCE** entitles you to participate in any authorised competition under the jurisdiction of Motorcycling Australia (M.A.)
- A **CLUB LICENCE** entitles you to participate in closed to club and interclub competition, under the jurisdiction of M.A.
- APPLICATIONS WHICH ARE NOT PROPERLY FILLED OUT WILL BE RETURNED TO YOU.**

 - that any policy of insurance of or in respect of my life or physical or mental health may be voided
 - that there may be no or inadequate facilities for treatment or transport of me if I am injured;
 - that I have an obligation to myself and others to compete safely and within the rules of competition
